SEASONAL COURT POLICIES:

1. Each player must affiliate himself/herself with Orange Lawn Tennis Club (the "Club") as a Full Orange Lawn Tennis Club Member or Indoor Tennis Member by completing and signing a membership application and paying the appropriate dues.
2. When the Club is responsible for lost playing time, make-up time will be scheduled based on court availability. Seasonal time unused by the playing group because of personal reasons cannot be made up. Missed court time due to a religious holiday will be rescheduled with the Captain based on court availability.
3. Use of courts beyond the assigned time will be subject to charge.
4. Captain and all players agree to abide by the rules and regulations of the Club.
5. If a seasonal court group has both Orange Lawn Tennis Club Members and Indoor Club Members, the Orange Lawn Tennis Club Members will receive a 10% discount on their pro-rata share of the court.
6. The Club reserves the right to terminate this Contract at any time for unsportsmanlike conduct on the part of any player or players, or for any other reason deemed to be good and sufficient by the Club's management, in which event, the unexpired portion of the court rental payment shall be returned to the Captain and neither the Club nor the Captain shall be under any further liability on account of this Contract. No refunds shall be given except as provided in this paragraph.
7. The Captain and all players acknowledge and agree that there are certain inherent dangers in playing tennis and that the Club shall not be liable for any personal injuries, property damage, or other loss sustained in, on or about the premises of the Club, or arising out of the use or intended use of any facilities, equipment or other property of the Club, whether or not said personal injuries, property damage, or other loss sustained is the result of the negligence of the owners, agents or employees of the Club or the negligence of any other persons present on the premises of the Club. These conditions apply individually and/or jointly with other players or guests of players.
8. All court assignments are at Club's discretion.
9. Captain and all players understand and agree that the Club retains the rights to any photographs or video taken at the facility to be used for marketing, publicity or advertising purposes.
